5. SUBJECT: Purchase of BMW Police Motorcycles

6. RECOMMENDATION: Staff recommends City Council approve the utilization of the State of Arizona Contract No. ADSP013-038704, with LZ Delta, LLC, dba GoAZ, for the purchase of eight BMW police motorcycles, in the amount of \$216,011.92.

7. BACKGROUND/DISCUSSION: As part of the vehicle replacement program evaluation process for FY 16/17, the Police Department submitted eight motorcycles from Field Operations, Traffic Investigation and Enforcement to be evaluated for replacement. The City's Fleet Advisory Committee (FAC) evaluates all vehicle replacement requests based on safety, mileage, years of service, reliability, repair history and forecasted ability to meet service requirements. The BMW motorcycles will replace eight of the Honda motorcycles currently in service. This recommendation is based on the overall performance, service turnaround time and design of this motorcycle. The BMW motorcycle comes equipped specifically for police work including greater capacity to handle the weight of the equipment installed on the motorcycle. The FAC recommended the replacement of the eight motorcycles. Their recommendation is supported by the Police Chief.

8. EVALUATION: The State of Arizona competitively solicited and awarded contracts for police motorcycles. The award for the purchase of the BMW police motorcycles was made to LZ Delta, LLC, dba GoAZ on January 3, 2013. Staff searched for other contracts for BMW police motorcycles to compare to the pricing of the State contract and found none. Staff is recommending use of the State contract because LZ Delta, LLC, dba GoAZ has provided excellent service to the City on its current motorcycle fleet. Additionally, LZ Delta, LLC, dba GoAZ is experienced with the final upfit requirements for Chandler's police motorcycles.
