RECOMMENDATION

Staff recommends that an additional continuance be given for the Series 12 Restaurant Liquor License for Dragana Cosic, Agent, SCDC Properties LLC, dba VB Lounge & Restaurant, located at 81 W. Boston Street until September 15, 2016.

With a Series 12, Restaurant Liquor License, the business may sell all liquors for on-premise consumption only, with a minimum of 40% of the gross receipts from the sale of food.

This additional continuance is requested to allow the applicant time to complete the requirements for a new Use Permit.
