5. SUBJECT: Contract Amendment No. 1 extending Annual Architecture Services with Dieterich Architectural Group, Inc.

6. RECOMMENDATION: Staff recommends City Council approve Contract Amendment No. 1 extending Annual Architecture Services, Contract No. EN1502.101, with Dieterich Architectural Group, Inc., in an amount not to exceed \$150,000 per year, for a two (2) year term.

7. BACKGROUND/DISCUSSION: Staff anticipates needing services related to Architecture Services in support of the Capital Improvement Program. City Council approved the initial contract on September 11, 2014, with the option to renew for a single two (2) year term. Dependent upon the project architecture needs, work will rotate among three (3) firms based on availability and expertise. This action will save on the cost of the selection process and time to bring individual projects forward.

8. EVALUATION: Consultant selection was conducted in accordance with established City policies and procedures. On June 24, 2014, staff received Statements of Qualifications from twelve (12) firms for Engineering/Consultant Services for Architecture Services. The Selection Committee reviewed the qualifications and chose three (3) firms for recommendation.

Staff recommends a contract extension to Dieterich Architectural Group, Inc. The term of this extension is September 17, 2016, through September 16, 2018. Work pursuant to this contract will be issued by individual project agreements. Project agreements exceeding \$30,000 will require City Council approval.

9. FINANCIAL IMPLICATIONS: Staff anticipates up to \$150,000 per year, for two (2) years, will be spent on Architecture Services. The owner/user department shall provide funding for each individual project requiring Architecture Services. The contract amendment includes a proposed average five percent increase in hourly rates.

10. PROPOSED MOTION: Move City Council approve Contract Amendment No. 1 extending Annual Architecture Services, Contract No. EN1502.101, with Dieterich Architectural Group, Inc., in an amount not to exceed \$150,000 per year, for a two (2) year term.

AMENDMENT NUMBER ONE
ANNUAL CONTRACT FOR ENGINEERING SERVICES
PROJECT NUMBER EN1502.101

The City Council authorized the City of Chandler (hereinafter referred to as "CITY") and **Dieterich Architectural Group, Inc.**, an Arizona corporation, (hereinafter referred to as "ANNUAL CONSULTANT") to enter into an Annual Contract for Architecture services (hereinafter referred to as "CONTRACT") which was approved by the City Council on September 11, 2014 and executed on September 17, 2014.

WHEREAS, the CITY and Dieterich Architectural Group, Inc., intend pursuant to this Amendment to amend and extend this CONTRACT, as amended, for the term September 17, 2016 through September 16, 2018; and

NOW, THEREFORE, in consideration of the mutual covenants and provisions contained herein and other good and valuable consideration, the parties do agree as follows:

1. This amendment is hereby incorporated to the CONTRACT and must be filed with the City Clerk's Office.
2. Sections 1.1 and 4.2 of this CONTRACT shall remain unchanged. CITY shall pay ANNUAL CONSULTANT an amount not to exceed One Hundred Fifty Thousand Dollars (\$150,000). Project Agreements exceeding Thirty Thousand Dollars shall require City Council approval.
3. Section 5.1 of this CONTRACT is amended to extend it for an additional term from September 17, 2016 through September 16, 2018.
4. City shall pay ANNUAL CONSULTANT for each Project an amount not to exceed that specified in each Project Agreement based on the rates shown on the Fee Schedule attached to this Amendment One as "REVISED EXHIBIT B FEE SCHEDULE RATES – EFFECTIVE 2016".
5. All other terms and conditions of the above referenced CONTRACT shall remain unchanged and in full force and effect.




