SUBJECT: NEW LICENSE SERIES 10 BEER AND WINE STORE LIQUOR LICENSE APPLICATION FOR NORELAIN GASTELUM ARMENTA, AGENT, WINGFOOT LLC, DBA WINGFOOT MINI MART

RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 10076812, and further, that approval be given for the City of Chandler Series 10, Beer and Wine Store Liquor License No. 161695 L10, for Norelaine Gastelum Armenta, Agent, Wingfoot LLC, dba Wingfoot Mini Mart, located at 629 E. Chandler Boulevard, Suite 3.

DISCUSSION

The following application for a liquor license was posted for hearing on October 13, 2016:

New License, Series 10, Beer and Wine Store Liquor License, for Norelaine Gastelum Armenta, Agent, Wingfoot LLC, dba Wingfoot Mini Mart, located at 629 E. Chandler Boulevard, Suite 3.


The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 10, Beer and Wine Store Liquor License, the business may sell beer and wine only for off-premise consumption.

The Planning Division advises a new Use Permit is not required since this will be a continuation of the location's previous use as The Lady LLC, dba Wingfoot Store.
