SUBJECT: NEW LICENSE SERIES 6 BAR LIQUOR LICENSE APPLICATION FOR CLARE HOLLIE ABEL, AGENT, HARKINS CHANDLER CROSSROADS LLC, DBA HARKINS THEATRE AT CHANDLER CROSSROADS

RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 06070139, and further, that approval be given for the City of Chandler Series 6, Bar Liquor License No. 113895 L6, for Clare Hollie Abel, Agent, Harkins Chandler Crossroads LLC, dba Harkins Theatre at Chandler Crossroads, located at 2980 E. Germann Road.

DISCUSSION

The following application for a liquor license was posted for hearing on November 10, 2016:

New License, Series 6, Bar Liquor License, for Clare Hollie Abel, Agent, Harkins Chandler Crossroads LLC, dba Harkins Theatre at Chandler Crossroads, located at 2980 E. Germann Road.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 6, Bar Liquor License, the business may sell all alcoholic beverages for on- or off-premise consumption.

The applicant's Use Permit through the Planning Division is also scheduled for this meeting.


