RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 06070623, and further, that approval be given for the City of Chandler Series 6, Bar Liquor License No. 110619 L06, for Anita Lynell Hobbs, Agent, Makk Enterprises LLC, dba Tom Ryans Lounge at 70 W. Warner Rd. Ste. 105.

BACKGROUND

This application reflects a change in ownership. Planning and Development advises that a new Use Permit is not required since this will be a continuation of the location's previous use as Tom Ryan's Lounge.

DISCUSSION

The following application for a transfer of a liquor license has been posted and published for hearing on January 11, 2007:

Series 6, Bar Liquor License, for Anita Lynell Hobbs, Agent, Makk Enterprises LLC, dba Tom Ryans Lounge, at 70 W. Warner Rd. Ste. 105.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 6, Bar Liquor License, the business may sell all alcoholic beverages for on or off-premise consumption.




