RECOMMENDATION

Staff recommends that an additional continuance be given for the Series 7, Beer and Wine Bar Liquor License Application, for Lori A. Tapia, Agent, Alas De Oro LLC, dba Ibiza Blue Restaurante at 1964 N. Alma School Rd., Ste. 1-4 until February 22, 2007.

RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 07070374, and further, that approval be given for the City of Chandler Series 7, Beer and Wine Bar Liquor License No. 110732 L07, for Lori A. Tapia, Agent, Alas De Oro LLC, dba Ibiza Blue Restaurante at 1964 N. Alma School Rd., Ste. 1-4.

BACKGROUND

This application represents a change of ownership for Mariscos Mi Lindo Mazatlan. On October 13, 2005, Mariscos Mi Lindo Mazatlan was approved for a Series 7 Liquor License; however, the corresponding Use Permit had a one-year stipulation that is due to expire. This applicant's new Use Permit through Planning and Development is also scheduled for this meeting.

DISCUSSION

The following application for a liquor license was posted and published for hearing on January 11, 2007, at which time it was continued until February 8, 2007:

Series 7, Beer and Wine Bar Liquor License, for Lori A. Tapia, Agent, Alas De Oro LLC, dba Ibiza Blue Restaurante, at 1964 N. Alma School Rd., Ste. 1-4.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 7, Beer and Wine Bar Liquor License the business may sell beer and wine only for on- or off-premise consumption.






