**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of State Liquor License No. 03073045, and further, that approval be given for the City of Chandler Series 3, Domestic Microbrewery License, No. 111265 L03, for Anthony Alfred Canecchia, Agent, San Tan Brewing Company, LLC, dba San Tan Brewing Company at 8 S. San Marcos Pl.

**DISCUSSION**

The following application for a liquor license has been posted and published for hearing on March 22, 2007:

New License, Series 3, Domestic Microbrewery License, for Anthony Alfred Canecchia, Agent, San Tan Brewing Company, LLC dba San Tan Brewing Company, at 8 S. San Marcos Pl.

**Consideration may be given to the applicant's personal qualifications and to the location.**

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 3, the business may manufacture or produce at least ten thousand (10,000) gallons, but less than three hundred ten thousand (310,000) gallons of beer annually.

The applicant's Use Permit through Planning and Development is also scheduled for this meeting.

**PROPOSED MOTION**

Move for recommendation to the State Department of Liquor Licenses and Control for approval of a Series 3, Domestic Microbrewery License, for San Tan Brewing Company, LLC, dba San Tan Brewing Company, 8 S. San Marcos Pl., and approval of the City of Chandler Liquor License.






