1. CANVASS: May 15, 2007 Bond Election Res. #4080

ADOPTED Resolution No. 4080 adopting the certificate of result of the Special Bond Election held May 15, 2007.

City Clerk Marla Paddock noted that out of the 10 bond questions, 9 were approved and one did not receive a majority of votes cast, Question #10 regarding the Airport Runway Extension. There was approximately a 12% voter turnout.

MIKE CORCORAN, 3365 S. Holly Ct., Chandler, addressed the Council as a member of the Concerned Citizens of Chandler who are opposed to runway extensions. He stated that after the extension question failed for the third time, airport supporter John Walkup commented that the ordinance requiring voter approval must go and be put it in the hands of government who know what's best. He stated that Mr. Walkup also said that the voters have a lack of education, the public is not aware and do not understand. Mr. Corcoran said the issue should be declared dead and no more tax dollars should be spent to promote it. These are Chandler residents and not county island residents who have voted this measure down three times.

MOVED BY COUNCILMEMBER ORLANDO, SECONDED BY COUNCILMEMBER SEPULVEDA, TO ADOPT RESOLUTION NO. 4080 CERTIFYING THE RESULTS OF THE BOND ELECTION AND CANVASS OF THE MAY 15, 2007 BOND ELECTION.
