**5. SUBJECT:** Renewal of agreement with Arizona Behavioral Counseling (ABC) for Operation of Alcohol/Substance Abuse and Domestic Violence Screening Facilities.

**6. RECOMMENDATION:** Recommend renewal of agreement with ABC for Operation of Alcohol/Substance Abuse and Domestic Violence Screening Facilities, RFQ No. MG9-0807-1563.

**7. HISTORICAL BACKGROUND/DISCUSSION:** Pursuant to A.R.S. Section 28-1381 et seq. a defendant convicted of an offense of A.R.S. Section 28-1381 shall be required to attend an alcohol abuse screening session at the defendant's expense. Defendants convicted of violations of other statutes may be ordered to be screened for substance abuse, domestic violence, and/or behavioral issues at their expense. ABC has been selected to provide this service for the Chandler Municipal Court.

**8. EVALUATION PROCESS:** In June 1999, Council awarded an agreement for operation of alcohol/substance abuse and domestic violence screening facilities to ABC. The agreement has a renewable option for one year increments at the discretion of the Presiding City Magistrate. Staff is satisfied with the service being provided by ABC and is requesting a one year extension. ABC has agreed to a one year extension with a \$5.00 increase in the screening fees.

**9. FINANCIAL IMPLICATIONS:** The fees paid to ABC are paid by the defendants.

**10. PROPOSED MOTION:** Move to approve renewal of Agreement with ABC for Operation of Alcohol/Substance Abuse and Domestic Violence Screening Facilities, RFQ No. MG9-0807-1563 per staff recommendation.
