5. **SUBJECT:** Extend Contract No. CS4-964-2091 for Various Sports Officials to Spiker Sports for one year in an amount not to exceed \$36,000.

6. **RECOMMENDATION:** Recommend the extension of Contract No. CS4-964-2091 for Various Sports Officials to Spiker Sports for one year in an amount not to exceed \$36,000.

7. **HISTORICAL BACKGROUND/DISCUSSION:** These services are required to operate the adult sports programs. Contractor provides sport officials for flag football, basketball and volleyball leagues/tournaments. Games are played (3) three seasons per year, (except flag football, which is played twice a year) 9-11 weeks per season totaling approximately 757 games per year.


8. **EVALUATION PROCESS:** In June 2004, a Contract for various sports officials was awarded to Spiker Sports for one year with three (3) optional one-year renewals. The contract was extended in 2005 and 2006. The contractor has agreed to the third and final extension of the contract with a price increase. The costs of this contract are recovered through registration fees paid by participants in the adult sports leagues. Staff has monitored the contract and is satisfied with the service being provided by Spiker Sports. Staff is requesting the contract be extended for one year for the period July 1, 2007 through June 30, 2008. By extending the contract, the City is avoiding administrative costs associated with rebidding.

9. **FINANCIAL IMPLICATIONS:** Funds for various Sport Officials will be from General Fund, Other Professional Contract Services, Account No. 101.4550.5219.







CITY OF CHANDLER  
AMENDMENT TO AGREEMENT  
VARIOUS SPORTS OFFICIALS  
PROJECT NO. CS4-964-2091

It is mutually agreed by and between the City of Chandler, hereinafter called CITY, and Spiker Sports, hereinafter called CONTRACTOR, that the AGREEMENT for Services for Various Sports Officials, Project No. CS4-964-2091 dated March 25, 2004, is hereby amended as follows:

- a. The agreement is extended for one year for the period July 1, 2007 through June 30, 2008.
- b. Price increase from \$20 per game/per basketball and football official to \$23 per game/per official. Increase from \$16 per game per volleyball official to \$17 per game effective July 1, 2007.
- c. The annual amount shall not exceed \$36,000;
- d. All other terms and conditions of the above referenced Agreement shall remain unchanged and in full force and effect.

All terms and conditions in the original Agreement not specifically amended herein shall remain in full force and effect.
