**5. SUBJECT:** Approve extension of an agreement for the purchase of liquid carbon dioxide with Praxair Inc., in an amount not to exceed \$36,600.

**6. RECOMMENDATION:** Recommend approval of an extension of an agreement for the purchase of liquid carbon dioxide with Praxair Inc., in an amount not to exceed \$36,600.

**7. HISTORICAL BACKGROUND/DISCUSSION:** Liquid carbon dioxide is used for pH control in the water treatment process.

**8. EVALUATION PROCESS:** The City of Glendale awarded cooperative contract #06-18, for the purchase of liquid carbon dioxide to Praxair Inc., for a one-year term ending June 30, 2007. The City of Chandler has been using this contract and is satisfied with the vendor's product and service. The contract allowed four one-year options to extend, and this is the first one-year extension. The price for liquid carbon dioxide for the term of July 1, 2007, through June 30, 2008, will increase to \$0.061 per lb. from \$0.0575 per lb. This price increase was approved by the City of Glendale and is acceptable to the City of Chandler.




