RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 06070064, and further, that approval be given for the City of Chandler Series 6, Bar Liquor License No. 114984 L06, for Gregory James Stanfield, Agent, Mirage Group Unlimited Inc., dba Regal Beagle Sports Lounge at 6045 W. Chandler Blvd., Ste. 7.

BACKGROUND

This application represents a change in ownership. Planning and Development advises that a new Use Permit is required since there was a stipulation on the previous Use Permit. The new Use Permit application will be heard at this same meeting.

DISCUSSION






