RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 12077233, and further, that approval be given for the City of Chandler Series 12, Restaurant Liquor License No. 115193 L12, for Adam Richard Stine, Agent, Stine Restaurant Group LLC, dba Qdoba Mexican Grill at 2855 W. Ray Rd. Ste. 1.

DISCUSSION

The following application for a liquor license was posted and published for hearing on September 20, 2007, at which time it was continued until October 25, 2007:

New license, Series 12, Restaurant Liquor License, for Adam Richard Stine, Agent, Stine Restaurant Group LLC, dba Qdoba Mexican Grill, at 2855 W. Ray Rd. Ste. 1.

Consideration may be given to the applicant's personal qualifications and to the location.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 12, Restaurant Liquor License the business may sell all liquors for on-premise consumption only, with a minimum of 40% of the gross receipts from the sale of food.

The applicant's Use Permit through Planning and Development is also scheduled for this meeting.






