RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 07070785, and further, that approval be given for the City of Chandler Series 7, Beer and Wine Bar Liquor License No. 112555 L07, for Duck Hong, Agent, Hollywood Billiards at 3029 N. Alma School Rd., Ste. 114.

DISCUSSION

The following application for a liquor license has been posted and published for hearing on December 13, 2007:

New License, Series 7, Beer and Wine Bar Liquor License, for Duck Hong, Agent, dba Hollywood Billiards, at 3029 N. Alma School Rd., Ste. 114.

Consideration may be given to the applicant's personal qualifications and to the location.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 7, Beer and Wine Bar Liquor License the business may sell beer and wine only for on-premise or off-premise consumption.

The applicant's Use Permit through Planning and Development is also scheduled for this meeting.






