SUBJECT: RESOLUTION NO. 4151 AUTHORIZING THE CITY MANAGER TO SIGN AND SUBMIT AN APPLICATION FOR THE MODIFICATION OF DESIGNATION OF ASSURED WATER SUPPLY

RECOMMENDATION: Staff recommends Council pass and adopt Resolution No. 4151 authorizing the City Manager to sign and submit an application for the Modification of Designation of Assured Water Supply.

BACKGROUND/DISCUSSION: The 1980 Groundwater Management Act requires that cities demonstrate they have 100-years of assured water supply (renewable water resource) for any proposed new development. Arizona Department of Water Resources (ADWR) granted Chandler a Designation of Assured Water Supply on December 31, 1997. This Designation demonstrated Chandler had sufficient renewable supplies to meet current and committed demands as of December 31, 1997 and projected demands through 2010.

Chandler has secured additional renewable supplies since the existing Designation was granted. An application to modify Chandler's Designation is being submitted to incorporate these additional supplies. Once approved, this modification will demonstrate Chandler has sufficient renewable supplies to meet current and committed demands as of December 31, 2007 and projected demands through 2020. The Assured and Adequate Water Supply Rules require that the City submit a resolution of its governing body authorizing the City Manager to sign the application.

Water Resources staff will be working closely with ADWR to provide any necessary information that will aid them in determining if the City's application is complete.

WHEREAS, Arizona Department of Water Resources Decision and Order No. 26-002009 designated the City of Chandler, Arizona as having an Assured Water Supply on December 31, 1997, demonstrating sufficient renewable water supplies were acquired to meet current and committed demands as of December 31, 1997 and projected demands through December 31, 2010; and

WHEREAS, pursuant to Order No. 26-002009 the City of Chandler, Arizona desires to submit an application to the Arizona Department of Water Resources requesting a modification of designation of assured water supply for the City of Chandler, Arizona to incorporate additional renewable water supplies acquired to meet projected demands through December 31, 2020; and

WHEREAS, Arizona Administrative Code Rule 12-15-710.B, requires that a City which is applying for a modification of an assured water supply designation submit a resolution of the governing body authorizing the City Manager to sign the application.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Chandler, Arizona, as follows:

Section 1. That the City Manager is authorized to sign the application, which is on file at the City Clerk's office, for the City of Chandler, Arizona to request a modification of designation of assured water supply pursuant to Arizona Administrative Code Rule 12-15-710.B.

Section 2. That the various City officers and employees are hereby authorized and directed to perform all acts necessary to give effect to this Resolution.


