5. SUBJECT: Extend use of Agreement No. ST6-750-2308 with Vulcan Materials Company for one year to provide ready mix concrete in an amount not to exceed \$ 75,000.

6. RECOMMENDATION: Recommend extending use of Agreement No. ST6-750-2308 with Vulcan Materials Company for one year to provide ready mix concrete in an amount not to exceed \$75,000.

7. BACKGROUND/DISCUSSION: Concrete ready mix is used by the Streets Division for sidewalk construction, curb and gutter repair, and miscellaneous concrete repairs. Aggregate slurry is used for sub-grade replacement. Staff is estimating 600 cubic yards of concrete and 200 cubic yards of aggregate slurry for the new agreement term for an estimated cost of \$ 75,000. The proposed agreement amount reflects anticipated usage and includes some funding for unanticipated needs.

8. EVALUATION PROCESS: In May 2006, Council awarded a one-year agreement, from July 1, 2006 to June 30, 2007, with four one-year extensions. This is the third extension of that agreement. Staff has monitored the agreement for the past year and is satisfied with the services provided by Vulcan Materials Company. The Contractor has agreed to extend the agreement for an additional year with no increase. The Agreement term will begin July 1, 2008. By extending the Agreement, the City will avoid administrative costs associated with rebidding.
