**5. SUBJECT:** Extend agreements for one year for Temporary Employees-Information Technology (RFP No. HR6-920-2279) with Ensynch, Inc., Judge Technical Staffing, Ablest Technology Services, MSS Technologies, At-Tech, Yoh Services LLC, ClientSolv Technologies, and Three Dimensional Resource Planning in a combined total not to exceed \$500,000.

**6. RECOMMENDATION:** Recommend extending agreements for one year for Temporary Employees-Information Technology (RFP No. HR6-920-2279) with Ensynch, Inc., Judge Technical Staffing, Ablest Technology Services, MSS Technologies, At-Tech, Yoh Services LLC, ClientSolv Technologies and, Three Dimensional Resource Planning in a combined total not to exceed \$500,000.

**7. HISTORICAL BACKGROUND/DISCUSSION:** The Information Technology Division has historically hired temporary employees to assist in special projects or who have specialized skills in a specific technical area. These employees complement the current Information Technology staff and are intended to work on a temporary basis for a specific assignment. City staff believes it is in the best interest of the City to contract with vendors that would assist the Information Technology Division. These vendors will identify temporary employees with specific technical skills that would work in this capacity. The Information Technology Division worked closely with the Human Resources Division in establishing an agreement with these vendors that was consistent with the City's hiring policies and practices for temporary employees.

**8. EVALUATION PROCESS:** In June 2006, Council awarded a two-year agreement to Ensynch, Inc., Judge Technical Staffing, Ablest Technology Services, MSS Technologies, At-Tech, Yoh Services LLC, ClientSolv Technologies and Three Dimensional Resource Planning to provide I.T. temporary services on an as-needed basis. The agreement expires June 30, 2008 and staff is requesting a one year extension to cover the period July 1, 2008 through June 30, 2009.

**9. FINANCIAL IMPLICATIONS:** Funds for Temporary Services – Information Technology will be from
