**SUBJECT:**        RESOLUTION 4190, PERTAINING TO THE SUBMISSION OF PROJECTS  
                         FOR CONSIDERATION IN ARIZONA'S 2009 HIGHWAY SAFETY PLAN

---

**SUMMARY:** The Governor's Office of Highway Safety (GOHS) has notified the department that they are requesting submission of proposals related to all aspects of highway safety for the 2009 Federal Fiscal Year, which commences on October 1, 2008.

**DISCUSSION:** In the past, this department has experienced success obtaining awards from GOHS, including three awards under the FY 2008 program for DUI Overtime, Occupant Protection Overtime, and a Gas Chromatograph. We anticipate submitting applications for award consideration in their FY 2009 program; however, we must first have a City Council approved resolution that must become part of our application package. This year the Police Department is submitting the following requests to GOHS for consideration in their 2009 budget:

1. DUI Enforcement Overtime - \$80,000 (salary and benefits)
2. Seatbelt Enforcement Overtime - \$21,491 (salary and benefits)
3. Equipment for DUI Vehicles - \$9,478
4. Six Laser Radar Units - \$19,008
5. Phlebotomy Supplies for DUI Enforcement - \$5,000

**FINANCIAL IMPLICATIONS:** None. Awards are funded by GOHS.

**RECOMMENDATION:** That the Mayor and City Council approve Resolution No. 4190.

**PROPOSED MOTION:** Move to approve City of Chandler Resolution 4190 pertaining to the submission of projects for consideration in Arizona's 2009 Highway Safety Plan.

Section II. THAT Sherry Kiyler, Police Chief, is appointed agent for the City of Chandler, to conduct all negotiations and to execute and submit all documents and any other necessary or desirable instruments in connection with such grant.
