5. **SUBJECT:** Extend Agreement No. CS7-964-2474 for Professional Softball Umpire Services with Southwest Umpire Association in an amount not to exceed \$60,000.

6. **RECOMMENDATION:** Recommend extending Agreement No. CS7-964-2474 for Professional Softball Umpire Services with Southwest Umpire Association in an amount not to exceed \$60,000.

7. **HISTORICAL BACKGROUND/DISCUSSION:** These services are required to operate the Men's, Men's Senior, Co-Recreational softball programs and invitational tournaments. Games are played three (3) seasons per year, 10-11 weeks per season, which could total as many as 3,000 games per year.


8. **EVALUATION PROCESS:** In August 2007, Council awarded a one-year agreement with three one-year optional extensions to Southwest Umpire Association. The agreement expires in August 2008, and staff is recommending a one year extension. In accordance with the original agreement, the fee will increase from \$22.00 per umpire to \$25.00 per umpire per game. Pricing is comparable to other local municipalities.

9. **FINANCIAL IMPLICATIONS:** Funds for Professional Softball Umpire Services will be from General Fund, Other Professional Contract Services, Account No. 101.4550.0000.5219.







AMENDMENT NO. 1
PROFESSIONAL SOFTBALL UMPIRE SERVICES
AGREEMENT NO. CS7-964-2474**

It is mutually agreed by and between the City of Chandler, hereinafter called CITY, and SOUTHWEST UMPIRES ASSOCIATION, hereinafter called CONTRACTOR, that the agreement for Professional Softball Umpire services, Project No., CS7-964-2474 dated 8-13-07, is hereby amended as follows:

WHEREAS, CITY awarded a contract to CONTRACTOR for professional softball umpire services in August 2007, for an initial one-year period with provisions to renew for up to three (3) additional years.

NOW THEREFORE, the parties agree as follows:

1. The agreement is extended for the first one-year option for the period August 9, 2008 through August 8, 2009;
2. The fee per umpire per game will increase from \$22.00 per umpire to \$25.00 per umpire per game.
3. All other terms and conditions of the above referenced Agreement shall remain unchanged and in full force and effect.
