The following application for a liquor license was posted and published for hearing on March 27, 2008, at which time it was continued until April 10, 2008, when it was further continued to May 22, 2008:


Series 9, Liquor Store Liquor License, for Jason Barclay Morris, Agent, Chandler Warner CVS, LLC dba CVS/pharmacy #9283, at 180 North Dobson Rd.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 9, Liquor Store Liquor License the business may sell all alcoholic beverages for off-premise consumption only.

The applicant's Use Permit through Planning and Development is also scheduled for this meeting.


