5. SUBJECT: Extend agreement BF4-998-2096 to: Brown Wholesale Electric; Electric Supply Inc; and Graybar for one year for the purchase of electrical supplies in a combined amount not to exceed \$320,000.

6. RECOMMENDATION: Recommend extending agreement BF4-998-2096 to: Brown Wholesale Electric; Electric Supply Inc; and Graybar for one year for the purchase of electrical supplies in a combined amount not to exceed \$320,000.

7. HISTORICAL BACKGROUND/DISCUSSION: Electrical supplies are stocked in the City's Central Supply Warehouse and used primarily by the Building & Facilities, Traffic, Water Production, Reverse Osmosis, and Park Development Divisions. Some of the products that are available under this contract include luminaires, photocells, ballast kits, traffic signal cable, and electrical wire.

8. EVALUATION PROCESS: In June 2004, Council awarded a one year agreement to Brown Wholesale Electric; Electric Supply, Inc.; and Graybar with provisions for four one year extensions upon mutual agreement between the City and the contractors. All pricing is based on a discount from manufacturer's list pricing. This is the final extension. By extending the agreement, the City will avoid administrative costs associated with rebidding.

9. FINANCIAL IMPLICATIONS: Funds for electrical parts and supplies will be from General Fund inventory account 101.0000.0000.1516. Individual cost centers will be charged for the supplies as they are issued.

10. PROPOSED MOTION: Approve extension of agreement BF4-998-2096 to: Brown Wholesale Electric; Electric Supply Inc; and Graybar for one year for the purchase of electrical supplies in a combined amount not to exceed \$320,000.
