5. **SUBJECT:** Extend agreement for Safety Footwear, RFP No. RM7-800-2450 to: Red Wing Shoe Store, JR's Shoes & Boots, Lehigh Safety Shoes, Industrial Shoes of Arizona, and American Safety Shoe Company for a total amount not to exceed \$35,000.

6. **RECOMMENDATION:** Recommend extending agreement RM7-800-2450 for Safety Footwear to: Red Wing Shoe Store, JR's Shoes & Boots, Lehigh Safety Shoes, Industrial Shoes of Arizona, and American Safety Shoe Company in an amount not to exceed \$35,000 for one year.

7. **HISTORICAL BACKGROUND/DISCUSSION:** City employees in several departments are required to wear Safety Footwear for their positions within the City. Since implementing a Safety Footwear program several years ago, City employees have had minimal foot injuries. In reviewing annual usage estimates, it was determined that it was in the best interest of the City to establish a term contract for the purchase of Safety Footwear.

8. **EVALUATION PROCESS:** In February 2007, staff issued proposal RM7-800-2450 for the purchase of Safety Footwear. The proposal was advertised and all registered vendors were notified. A total of 5 responses were received. After a thorough evaluation by the committee, Staff recommended awarding to all five respondents to allow employees' access to the vendors who provide mobile shoe service as well as making a wide variety of shoe brands available. Staff has been satisfied with the services provided by all vendors and would like to extend the agreement for an additional one year.

9. **FINANCIAL IMPLICATIONS:** Funds for purchase of Safety Footwear will be from the various Departments' accounts.

10. **PROPOSED MOTION:** Recommend extending agreement for Safety Footwear to: Red Wing Shoe Store, JR's Shoes & Boots, Lehigh Safety Shoes, Industrial Shoes of Arizona, and American Safety Shoe Company for the purchase of Safety Footwear in an amount not to exceed \$35,000 for one-year.




