6. RECOMMENDATION: Recommend approval of an extension of an agreement for the purchase of liquid carbon dioxide with Praxair, Inc., in an amount not to exceed \$38,400.

7. HISTORICAL BACKGROUND/DISCUSSION: Liquid carbon dioxide is used for pH control in the water treatment process at the surface water treatment plant.

8. EVALUATION PROCESS: A cooperative contract for the purchase of liquid carbon dioxide was awarded by the City of Glendale. The contract allowed four one-year options to extend, and this will be the second one-year extension. The price for the term of July 1, 2008, through June 30, 2009, will increase to \$0.064 per lb., from \$0.061 per lb. This price increase has been approved by the City of Glendale and is acceptable to the City of Chandler.



NOW THEREFORE, the parties agree as follows:


1. The term of this agreement is amended to extend the term of the Agreement from July 1, 2008 through June 30, 2009.


