**5. SUBJECT:** Approve Contract Amendment No. 2 in the amount of \$65,000 for Standard Details and Specifications Revisions and to increase the expenditure limit by \$65,000 on the agreement with Jeffers and Associates, PLLC, from \$515,000 to \$580,000.

**6. RECOMMENDATION:** Staff recommends that Council approve Contract Amendment No. 2 in the amount of \$65,000 for Standard Details and Specifications Revisions and to increase the expenditure limit by \$65,000 on the agreement with Jeffers and Associates, PLLC, from \$515,000 to \$580,000.

**7. BACKGROUND/DISCUSSION:** For more than 15 years, Development Services has contracted with various providers for civil engineering plan review to supplement staff. Jeffers and Associates, PLLC, is one of the current providers of plan review services. Due to the consultant's expertise and familiarity with the City's Standard Engineering Details and Specifications, Public Works requested that Jeffers and Associates, PLLC, assist with the incorporation of user feedback into the Standard Details. Council approved the first amendment to the original contract in October 2007.

Due to the unanticipated volume of feedback and the time involved in reviewing and incorporating these comments into the details, City staff is recommending that the contract amount be increased again to accommodate the additional effort.

**8. EVALUATION:** On November 16, 2006, Council approved a professional services agreement with Jeffers and Associates, PLLC, for Civil Plan Review Services. The consultant selection process was conducted in accordance with established City policies and procedures.

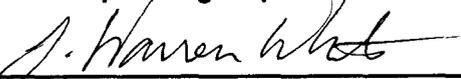

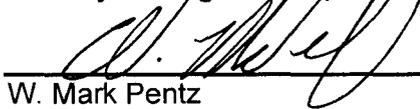

## EXHIBIT A SCOPE OF WORK

The Consultant shall provide hourly engineering services which include preparing and drafting updates and revisions to the current City of Chandler *Standard Details and Specifications* and the *Technical Design Manuals* (collectively, **the Standards**) as directed by City staff.

Such services shall include meeting with the City department staff to discuss needs and goals of the proposed revisions to the Standards. Markups of tentative changes will be prepared for City discussion, comment, and revision. Upon final direction from staff, Consultant shall execute such changes to the native computer format and deliver the resultant files to the City for adoption by the City Engineer.

The Consultant shall perform these services through a Civil Engineer (P.E.) and through other qualified personnel as may be required by Exhibit B, who are employed or retained by the Consultant.

As a registered professional engineer, Consultant may provide recommendations to improve the engineering standards. However, the inclusion of all such recommendations shall be done only at the discretion of the City Engineer and/or City engineering staff. Final approval of the engineering standards is the responsibility of the City Engineer.

**EXHIBIT B  
FEE SCHEDULE**

For services described in Exhibit A of the Agreement, the City shall pay the Consultant a fee per hour for **Standards Update** as follows:

Design-Drafting	\$71.50
Civil Engineer (P.E.)	\$105.00

The following reprographic costs will be reimbursed by the City at the following costs:

Digital Bond Printing	\$0.18 per sq ft
Digital Bond Plotting	\$0.65 per sq ft
BW 8.5x11	\$0.10 per impression
BW 11x17	\$0.25 per impression

Authorized mileage at the federal rate, and other authorized direct costs shall be reimbursed at cost.

Payment shall be made monthly on the basis of progress reports. Work schedule updates shall be included in the monthly progress payment requests.
