5. SUBJECT: Extend Agreement for one year for Legal Advertising Services with Phoenix Newspapers, Inc. dba The Arizona Republic in an amount not to exceed \$60,000

6. RECOMMENDATION: Recommend Agreement No. CC6-915-2195 for one year for Legal Advertising Services with Phoenix Newspapers, Inc. dba The Arizona Republic in an amount not to exceed \$60,000.

7. HISTORICAL BACKGROUND/DISCUSSION: The City Clerk is responsible for the publication of legal notices within the City. Legal notices are required for bids, zoning hearings, elections, ordinances and other public matters.

8. EVALUATION PROCESS: In August 2005, Council awarded a one-year Agreement with Phoenix Newspapers, Inc. dba/The Arizona Republic. The Agreement included an option to extend four additional one-year periods upon mutual agreement between the City and the Contractor. The Agreement expires September 30, 2008, and staff is requesting a third one-year extension. The Contractor has agreed to extend the Agreement under the current terms and conditions.

9. FINANCIAL IMPLICATIONS: Funds are available in General Fund, City Clerk, Legal Advertising, 101.1030.0000.5513.

10. PROPOSED MOTION: Recommend extending Agreement No. CC6-915-2195 for one year for Legal Advertising Services with Phoenix Newspapers, Inc. dba The Arizona Republic in an amount not to exceed \$60,000 per staff recommendation.





INC. dba/THE ARIZONA REPUBLIC
FOR LEGAL ADVERTISEMENT SERVICES AGREEMENT NO. NO. CC6-915-2195

This Amendment # 4 to that certain Agreement Between the City Of Chandler (CITY) and Phoenix Newspapers, Inc. dba/The Arizona Republic (CONTRACTOR) for Legal Advertisement Services dated August 25, 2005 and Amended on July 27, 2006 and Amended on July 26, 2007 is entered into this _____ day of _____, 2008.

WHEREAS, on August 25, 2005 the City of Chandler awarded a one year agreement to Phoenix Newspapers, Inc. dba/The Arizona Republic with four one year optional extensions for Legal Advertisement Services. The agreement was amended on July 27, 2006 and July 26, 2007 for one-year extensions.

NOW THEREFORE, the parties agree as follows:

1. The term of this agreement is amended to extend the term of the Agreement from September 1, 2008 through August 31, 2009
2. All terms and conditions in the original Agreement not specifically amended herein shall be incorporated by reference in its entirety and shall remain in full force and effect.
