5. **SUBJECT:** Extend agreement TE6-801-2290 for traffic signs and related items to Safeway Sign Company and Zumar Signs, for a one-year period, in a total amount not to exceed \$85,000.

6. **RECOMMENDATION:** Request the extension of agreement TE6-801-2290 for traffic signs and related items to Safeway Sign Company and Zumar Signs, for a one-year period, in a total amount not to exceed \$85,000.

7. **HISTORICAL BACKGROUND/DISCUSSION:** Annually, Traffic Engineering's preventive maintenance program replaces approximately 1000 traffic signs and posts. Posts and signs are replaced due to damage, age or installed for new requirements. A term contract is necessary to establish firm pricing and insure availability of these high use items when needed. The equipment will be distributed from Central Supply.

8. **EVALUATION PROCESS:** On May 25, 2006, Council approved agreement TE6-801-2290 for the purchase of traffic signs and related items to Safeway Sign Company and Zumar Signs for a one-year period with provisions for four one-year extensions. This will be the third extension to the agreement. Staff has monitored the agreement for the past year and is satisfied with the supplies provided by Safeway Sign Company and Zumar Signs and is requesting a fourth year extension of the contract. Both vendors have agreed to extend the contract without any price increases. The new term will be June 1, 2009 through May 31, 2010.

9. **FINANCIAL IMPLICATIONS:** Funds for purchase of traffic signs and related items will be from the Central Supply Inventory account 101.0000.0000.1516 and charged back to individual cost centers for the supplies as they are issued.

10. **PROPOSED MOTION:** Move to extend agreement TE6-801-2290 for traffic signs and related items to Safeway Sign Company and Zumar Signs for the purchase of traffic signs and related items, for a one-year period, in a total amount not to exceed \$85,000.



NOW THEREFORE, the parties agree as follows:


1. Section 6 of the AGREEMENT is hereby amended to extend the AGREEMENT for a one-year period, June 1, 2009 through May 31, 2010.
