**RECOMMENDATION**

Staff recommends Council forward a recommendation for approval of State Liquor License No. 12078019, and further, that approval be given for the City of Chandler Series 12, Restaurant Liquor License No. 125086 L12, for Shana Kathleen Reese, Agent, Blazin Wings Inc., dba Buffalo Wild Wings Grill & Bar at 3163 W. Chandler Blvd., Ste. 1.

**DISCUSSION**

The following application for a liquor license has been posted and published for hearing on June 25, 2009:

New License, Series 12, Restaurant Liquor License for Shana Kathleen Reese, Agent, Blazin Wings Inc., dba Buffalo Wild Wings Grill & Bar, at 3163 W. Chandler Blvd., Ste. 1.

**Consideration may be given to the applicant's personal qualifications and to the location.**

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 12, Restaurant Liquor License the business may sell all liquors for on-premise consumption only, with a minimum of 40% of the gross receipts from the sale of food.


Planning and Development advises a new Use Permit is not required since this will be a continuation of the location's previous use as Red Kilt Grill and Pub.
