5. SUBJECT: Approve extension of agreement #FA9-340-2643 for the purchase of fire uniforms with United Fire Equipment Company, in an amount not to exceed \$159,000.

6. RECOMMENDATION: Recommend approval of the extension of contract #FA9-340-2643 for the purchase of fire uniforms with United Fire Equipment Company, in an amount not to exceed \$159,000.

7. HISTORICAL BACKGROUND/DISCUSSION: The Fire Department provides members with an annual uniform allowance. This allowance is \$675/year, for sworn personnel and \$300/year for non-sworn personnel. As uniforms are purchased throughout the year, amounts are deducted from each member's account. The account balances are tracked by the vendor and billing invoices are sent to Fire Administration monthly. This helps to insure that our members present the best appearance to the public and that they are provided with uniform items that meet national standards for safety.

8. EVALUATION PROCESS: In August 2008, Council awarded a one-year agreement for the purchase of fire uniforms. The contractor, United Fire Equipment Company, has agreed to extend the agreement for the first of four additional one-year periods with no price increase. The term of the agreement will be August 15, 2009 through August 14, 2010.

9. FINANCIAL IMPLICATIONS: Funds are available from 101.2210.5313, General Fund, Fire Administration, Clothing and Uniforms.

10. PROPOSED MOTION: Move to approve the extension of contract #FA9-340-2643 for the purchase of Fire Uniforms with United Fire Equipment Company, in an amount not to exceed \$159,000.


