SUBJECT: UP09-0018 NATE'S THIRD BASE RESTAURANT

Request: Use Permit approval to allow liquor sales and service as permitted under a Series 12 Restaurant License for on-premise consumption indoors and within an outdoor patio at a new restaurant.

Location: 1949 West Ray Road, Suite 11, within the Boardwalk at Andersen Springs at the southeast corner of Ray and Dobson Roads

Applicant: Nate Myres

RECOMMENDATION

The application requests Use Permit approval to allow liquor sales as permitted under a Series 12 Restaurant License for on-premise consumption indoors and within an outdoor patio at a new restaurant within an existing commercial center. Planning Commission and Staff, finding consistency with the General Plan and Planned Area Development (PAD) zoning, recommend approval.

BACKGROUND

A Series 12 license, which is considered a “restaurant license,” allows the on-site sale of beer, wine, and spirits for on-site consumption. Under a Series 12 license, the establishment must derive at least forty (40) percent of its gross revenue from the sale of food.

The subject property is located at the southeast corner of Ray and Dobson Roads within the Boardwalk at Andersen Springs Shopping Center. This center is zoned Planned Area Development (PAD) and is surrounded by a man-made lake and condominiums to the south and east, a shopping center to the north across Ray Road, and single-family homes to the west across Dobson Road.

Since 1997, the Groovy Mundo and Boardwalk Grill restaurants have occupied the restaurant tenant space. The original Use Permit for a Series 12 Restaurant License was issued to Waterfront Grill, LLC. The original restaurant owner, with the name changed to Groovy Mundo Grill, was issued a Series 6 Bar License with a 1-year time limit in September of 2000. The Series 6 License was issued with the understanding that the applicant acquire a Series 6 license for its catering business and for the operation of a full service restaurant and bar. The Use Permit excluded uses such as cocktail lounges and nightclubs. In October 2001, the restaurant was sold to the second owner who chose to emphasize the restaurant's menu and food service. The new owner, keeping the restaurant's name Groovy Mundo Grill, applied for and received a Series 12 Restaurant License without expiration.

Ownership changed hands again in the years to follow with the third owner changing the restaurant's name back to the Waterfront Grill and offering a smaller bar menu, choosing later operating hours, and bringing in live entertainment. These changes altered the character of the business and the restaurant was no longer able to operate under the Series 12 License. Under a new (fourth) owner, the site received Use Permit approval for Series 6 Bar License Use Permit for one year in May 2006. The last liquor use permit was approved in 2007 as a Series 6 Bar License for Waterfront Grill with a one year time limit, which has since expired.

This current application requests approval of a Series 12 Restaurant License for a family-style American cuisine restaurant. The restaurant intends to be open Monday through Friday from 10 a.m. to 2 a.m. and Saturday/Sunday 8 a.m. to 2 a.m. The restaurant offers breakfast, lunch, and dinner menus as well as a kid's menu.

The restaurant is approximately 4,200 square foot with an outdoor patio along the lakefront of approximately 1,280 square feet (64 feet by 20 feet). The indoor dining area has 88 seats, the indoor bar area has 42 seats, and the outdoor dining area is planned to accommodate approximately 60 seats. The new restaurant is maintaining much of the interior layout and furnishings left by the previous restaurant. Interior entertainment amenities include one pool table, three arcade games, and televisions. The application requests to have live entertainment that would occur only in the afternoon once a week as an acoustic setup indoors only, no live bands or music at night. Karaoke would occur inside the restaurant one night a week.

PUBLIC / NEIGHBORHOOD NOTIFICATION

- The request was noticed in accordance with the requirements of the Chandler Zoning Code.
- The applicant's neighborhood meeting was held on June 15, 2009. No one attended other than the applicant.
- The Police Department has been informed of the application and has responded with no issues or concerns.
- At the time of the memo, Staff is not aware of any opposition to this request. Staff has received a couple of phone calls from area residents excited the restaurant is opening again and support the liquor use permit request.

RECOMMENDED ACTION

Planning Commission and Staff, upon finding consistency with the General Plan and PAD zoning, recommend approval of Use Permit UP09-0018 NATE'S THIRD BASE RESTAURANT, subject to the following conditions:


1. Expansion, modification, or relocation beyond the approved exhibits (Site Plan, Floor Plan, and Narrative) shall void the Use Permit and require new Use Permit re-application and approval.
2. The Use Permit is granted for a Series 12 license only, and any change of licenses shall require re-application and new Use Permit approval.
3. The Use Permit is non-transferable to other restaurant locations.
4. The site shall be maintained in a clean and orderly manner.
5. The patio shall be maintained in a clean and orderly manner.
6. There shall be no live entertainment outdoors including acoustic groups, bands, and the like.
7. Indoor music is limited to an acoustic group and karaoke no more than once a week for each. Any change in entertainment including pool tables, arcade games, live music, and the like shall require re-application and new Use Permit approval.
8. Noise shall be controlled so as to not cause a nuisance for nearby residences.


Ray Rd.

This narrative is respectfully submitted for your consideration in the issuing of a Liquor Use Permit for a series 12 liquor license at the location of 1949 E. Ray Road, Suite 11, Chandler, AZ 85224.


This space will be known as Nate's Third Base Restaurant. It will be a family style American cuisine restaurant with a large menu that includes many different types of food at a reasonable price that families can afford. We will be open Monday through Friday 10am to 2am. Saturday and Sunday we will be opening at 8 am. We will offer separate breakfast, lunch and dinner menus as well as a kids menu. The restaurant space is 4200 square feet and the patio is 64 ft by 20 ft and is well more than twenty feet from any entrance to any business. We anticipate opening with 10 employees, including my wife and I, who have attended liquor training classes and have food handlers cards. We plan on having one pool table, three arcade games, televisions and possibly a claw machine for entertainment. Any form of live music would be in the afternoon with an acoustic set up, not a loud band at night. We might have karaoke, inside, one night a week. We have not made any structural changes inside or outside of the business. We have added new paint to brighten up the space and added booth seating. It is our intention to not only serve the citizens of Chandler and their families, but also the employees of the surrounding businesses.


