RECOMMENDATION

Staff recommends Council forward a recommendation for approval of State Liquor License No. 10075789, and further, that approval be given for the City of Chandler Series 10, Beer and Wine Store Liquor License No. 124890 L10, for Kim Kenneth Kwiatkowski, Agent, Circle K Stores Inc., dba Circle K Store #9182 at 3989 W. Ray Rd.

BACKGROUND

This application reflects a change in ownership. Planning and Development advises that a new Use Permit is not required since this will be a continuation of the location's previous use as Mobil On The Run # 15018.

DISCUSSION

The following application for a liquor license has been posted and published for hearing on July 30, 2009:

New License, Series 10, Beer and Wine Store Liquor License, for Kim Kenneth Kwiatkowski, Agent, Circle K Stores Inc., dba Circle K Store #9182, at 3989 W. Ray Rd.

Consideration may be given only to the applicant's personal qualifications and to the location.

The Police Department reports no objections to the issuance of this license, and no written protests pursuant to A.R.S. 4-201(B) have been received. All licenses, permits, and fees have been paid, and the applicant is in compliance with the City's Tax Code. With a Series 10, Beer and Wine Store Liquor License the business may sell beer and wine only for off-premise consumption.






