SUBJECT: LUP09-1003 HEART N SOUL BAR AND GRILL

Request: Approval of a Use Permit to sell liquor as permitted under a Series 12 Restaurant License for on-premise consumption indoors only at a new restaurant within the McRay Plaza

Location: 3855 West Ray Road, Suite 6-7 the southeast corner of Ray Road and McClintock Drive

Applicant: Cindy Rodriguez, owner

RECOMMENDATION

The application requests approval of a liquor Use Permit as permitted under a Series 12 Restaurant License for on-premise consumption indoors only. The restaurant is located within the McRay Plaza retail center. Planning Commission and Staff, finding consistency with the General Plan and PAD zoning, recommend approval.

BACKGROUND

The restaurant is locating in an in-line shops building south of the AMF bowling facility. The new restaurant requests approval of a Series 12 Restaurant License, which allows the on-site sale of beer, wine, and spirits for on-site consumption. Under a Series 12 license, the establishment derives at least forty (40) percent of its gross revenue from the sale of food.

The restaurant space is approximately 1800 square feet in size with a seating capacity of 80 persons. The restaurant's hours of operation are Monday-Wednesday 10 a.m.-10 p.m., Thursday-

Saturday 10 a.m.-2a.m., and Sunday 10 a.m.-10 p.m. There is no outdoor dining area proposed with this request. A separate Liquor Use Permit is required for outdoor dining with liquor service and consumption. The restaurant proposes live entertainment, which will occur Thursday through Saturday. Live entertainment includes jazz bands with amplified music. There will be no stage and the set up will be at the end of dining area.

Staff is recommending a couple of conditions related to potential noise disruptions arising from live music to the adjacent residential neighborhood.

PUBLIC / NEIGHBORHOOD NOTIFICATION

- The request was noticed in accordance with the requirements of the Chandler Zoning Code.
- The applicant's neighborhood meeting is scheduled for September 21, 2009. There were no attendees other than the applicant.
- Staff received one phone call from a homeowner behind the shopping center inquiring about the new type of restaurant and if any music was proposed. The homeowner requested there be a condition limiting noise.
- The Police Department has been informed of the application and has responded with no issues or concerns.

RECOMMENDED ACTION

Planning Commission and Staff, upon finding consistency with the General Plan and PAD zoning, recommend approval of LUP09-1003 HEART N SOUL BAR AND GRILL Use Permit, subject to the following conditions:

1. Expansion, modification, or relocation beyond the approved exhibits (Site Plan, Floor Plan, and Narrative) shall void the Use Permit and require new Use Permit re-application and approval.
2. Any substantial change in the floor plan to include such items as, but not limited to, additional bar serving area or additional entertainment related uses shall require re-application and approval of the Use Permit.
3. The Use Permit is non-transferable to other restaurant locations.
4. No noise shall be emitted so that it exceeds the general level of noise emitted by uses outside the premises of the business and as not to disturb adjacent businesses and residential areas.
5. The rear door to this business shall remain closed during businesses hours and not be propped open in the evening as to disturb adjacent homeowners when there is live entertainment.



6. The site shall be maintained in a clean and orderly manner.

PROPOSED MOTION


Move to approve Use Permit LUP09-1003 HEART N SOUL BAR AND GRILL, subject to the conditions recommended by Planning Commission and Staff.




