- Fee assistance funds do not cover items such as supply fees.
- Please allow at least 7-10 business days prior to the upcoming session registration period or class start date for application processing.
- Participants must follow the Aquatic Division's refund / cancellation policy. The Community and Neighborhood Services Department reserves the right to revoke the fee assistance for participants who cancel classes excessively or fail to follow the refund/cancellation policy.
- All family members in the household must be noted on the application. Only dependents living in the household who are listed on the application will be approved to use fee assistance funds.
- Please report your household income based on your 2014 or most recent federal tax return, W-2(s) or 1099(s) for all members living in the household who receive any form of income.
