

NOTICE OF PUBLIC HEARING

ADOPTION OF 2013-14 BUDGET AND 2014-2023 CAPITAL IMPROVEMENT PROGRAM AND SETTING OF PROPERTY TAX LEVIES

NOTICE IS HEREBY GIVEN THAT at a Regular Meeting of the City Council of the City of Chandler, the Council shall hold a public hearing. The City Council will meet for the purpose of final hearing of taxpayers, for adoption of the 2013-14 Annual Budget and the 2014-2023 Ten Year Capital Improvement Program (CIP), and for hearing taxpayers on the proposed property tax levies for the City of Chandler, Arizona, on the 13th day of June, 2013, at the hour of 7:00 p.m. in the Council Chambers, 88 East Chicago Street, Chandler, Arizona, and will further meet for the purpose of setting the property tax levies on the 27th day of June, 2013, at the hour of 7:00 p.m. in the Council Chambers, 88 East Chicago Street, Chandler, Arizona.

The estimates of the amounts required for the public expense for the City of Chandler for fiscal year 2013-14 and required under §42-17101 and §42-17102 described in Schedules A through G have been tentatively adopted by Resolution No. 4685 on May 23, 2013, and are attached hereto.
