#### Legislative Update

Federal Funding -2.2 trillion dollar stimulus package to address the needs of programs, survivors and advocates. Gaps still remain including no specific funding for sexual assault, that the incoming  $4^{th}$  package is hoping to address.

Emergency Funding 18.3 billion dollars bill focused on COVID-19 vaccine research and development & Phase 2 signed into law mid-March which largely focused on paid sick leave and unemployment benefits for workers and families and supported survivors.

Phase 3 is CARES Act. Coronavirus Aide Relief and Economic Securities Act signed into law on March 27<sup>th</sup> to provide more additional relief due to the pandemic. CARES Act did include 45 million dollars for Family Violence Prevention and Services Act (FVPSA), with a match waiver. It appears 75% was going to the states, 10% was going to the state dual coalitions, and 10% was going to the tribal communities, with the remaining funds going to administration. The FVPSA Office was very much on board with this, as far as the needs and the programs for the spending, whether it is for hotels, motels, rental assistance – because the needs of survivors are definitely more complex right now. The amount anticipated to come to Arizona was approximately \$600,000. The CARES Act also expanded on employment insurance provisions and invested seriously in housing and homelessness, by the way of emergency solutions grant. This also provided the direct stimulus economic impact payments (\$1200 adult/\$600 children with some requirements). It also supplied business loans helping nonprofits, additional SNAP and Child Nutrition Program and Emergency Food Assistance, as well as Programs Appropriation. Funding was also for Legal Services corporations and an increase in Community Services Block Grant, Child Care Development Block Grants, and additional appropriations for Runaway and Homeless Youth. The CARES Act Emergency Funding was supplemental, so what was passed in December 2019 was actually for Fiscal Year 20. So this is new funding but not tied to a specific Fiscal Year. Our national partners, with the Arizona Coalition to End Sexual and Domestic Violence working alongside them, are working on the lobbying for the next Phase, the Fiscal Year 21 appropriations. The timing for advocacies coming down to the state and local levels will take some time.

Following the CARES Act was an interim legislation that was being called Phase 3.5. That was passed on April 23<sup>rd</sup>. The Paycheck Protection Program and Healthcare Enhancement Act. That provided the 484 billion dollars for small business lending, and also included 75 billion in funding for hospitals and 25 billion for COVID testing. There are still no additional funds for local and state government; this is still an issue. Again this was just the interim legislation that was meant to bridge the gap between the CARES Act and Phase 4, which has just been introduced.

Phase 4 was passed by the U.S. House of Representatives on May 15<sup>th</sup>. Phase 4 and introduced the HEROES Act, standing for the Health and Economic Recovery Omnibus Emergency Solutions Act. This actually includes critical funding and policy improvements to help address survivors' ongoing urgent housing, economic and other human needs during the pandemic. It's very comprehensive because the Senate has said that they're not really in a hurry to pass a 4<sup>th</sup> Stimulus Bill. They want to see how everything in the infrastructure from the previous funding and the CARES Act is actually reaching the states. This does include a fix to the Federal Crime Victim Fund providing non-taxpaver dollars to victim service providers in every state, hoping to create the sustainable funds for the future. This would also include an additional 48 million dollars for emergency shelter and services for survivors and children through FVPSA. There would also be the 100 million dollars Violence Against Women Act (VAWA) for programs which would include 15 million dollars for transitional housing and 1 billion dollars in housing vouchers for those experiencing homelessness, which would include survivors. This also includes police solutions for immigrant survivors, such as access to the stimulus payments for immigrants who pay taxes. Also there is an extension of immigration status or work authorization and access to testing treatment and care. This includes more funding for nutritional programs and SNAP, improvements and temporary assistance for needy families, and programs for low income survivors. This also would improve the employment and economic protections for workers that were passed in the CARES Act, by amending the use and ability to take paid sick and paid leave. This expands to caregiving and medical reasons for taking paid leave. Increasing wage replacement maximums for family care purposes and extending family care definitions. So with the HEROES Act, we are extremely grateful for the inclusion of survivor's specific funds in the VAWA and FVPSA. More is definitely still needed, so we're advocating alongside of our national partners in hoping that we will be able to get more Senate folks on our side, and make sure that they understand that the needs of survivors are evolving, especially during the pandemic. So the timeline to see the 4<sup>th</sup> packages of Stimulus is not expected until probably July. Recent talks are as early as August. They are not looking to approve anything more than a 1 trillion dollar Emergency Stimulus Package, so we will see how that goes. We will continue to advocate and stay on top of our members of Congress.

While we are advocating for the 4<sup>th</sup> package, there is also a new grant program that is being introduced out of the FVPSA office. It would be separate from the FVPSA funding, but that's to ensure that there is a health response for communities of color. This would be placed in the Health and Human Services and would include funding for domestic violence and sexual assault organizations, and for community based programs. It may be a slower process and it is not emergency funding, but something that the National Coalition is working on.

ACESDV's priority is establishing state sexual violence services funding and make changes in language regarding the termination of parental rights for survivor's children who are born as a result of a sexual assault.

HB 2391 was introduced and it was cited as the Violence Against Women Act (VAWA) of 2020 and not only established a 10 million dollar sexual assault services fund to be administered through Department of Economic Services, but this also would have expanded the confidentiality protections for domestic and sexual violence advocates to include any linguist interpreter. This unfortunately, was not made a part of any agenda and died this legislative session.

Senate Bill 1355 would have allowed the court to grant the petition to terminate parental rights if it was found by clear and convincing evidence that the child was conceived as a result of sexual assault committed by the parent who is the subject of the petition against the parent who filed the petition. Right now, the state requires a felony conviction which is resulting in only 2%. We were hoping to expand the language to clear and convincing evidence to be consistent with at least 26 other states across the country. This was actually placed on the Judiciary Committee Agenda, but excluded all married survivors. The decision was made to hold this in committee and then revisit it in future sessions.

The House and Senate Democrats introduced their own "The People's Budget" which allowed a 5 million dollar line item to be allocated for state sexual violence services. But while budget negotiations were under way, that is when COVID struck. The State Legislature passed the "The Skinny Budget" which left this one and hundreds of bills outstanding. Over 1,700 pieces of legislation were introduced this session. Less than 100 were signed into law, making this an all-time low. The House and the Senate Democrats are advocating for the need to come back for a special session to deal with appropriation and policy issues and would also like to defer the conversation for any budget cuts or potential revisions for possibly a third session. Some more experienced lobbyists have shared that it could be a one day session. A lot of the ground work is done before they come back into special session. Good news is leadership is working on that now and they are looking at how people can come back to work safely.

Joint Legislative Committee introduced an anticipated shortfall of 1.1 billion dollars by the FY21 for the state's general fund. This week they mentioned that things may not have been as bad as originally thought, so they will revisit that in June. The special sessions that are incoming probably will not start any earlier than June 22.

ACESDV is staying vigilant to make sure lawmakers do not go after any funding cuts that would be detrimental for our community or constituents. Still looking at federal funding that might come in and the fourth phase of stimulus funding, where we can lobby for survivors, programs, and technology needs for all of our programs at this time.

Criminal justice professionals and advocacy groups have concerns that children and adults are not having contact with many people outside of their home and children are not around Mandatory Reporters, so some of the child abuse and domestic violence crimes have just not been reported. The predictions are that when children return to school there will be an increase in the number of reports to police and the Department of Child Safety.

Below are the Chandler Police Department numbers of reports (general offenses) written by officers for all Domestic Violence related general offenses and Child Abuse/Neglect of Child general offenses for the months of March and April 2018/2019/2020 for comparison.
