- 2. Bid due date has been changed. Sealed bids must be delivered to the City of Chandler Capital Projects Office located at 215 East Buffalo Street, Chandler, Arizona, 85225. Bids must be received on or before **3:00 p.m. local Arizona time on January 12, 2023**.
- 3. Replace Plan Sheet 3 in its entirety with the attached Plan Sheet 3 dated January 3, 2023.
- 4. Questions:
 - 1. Question 1 Plan Sheet No. 2, General Note #8 States the Following. "No final acceptance shall be issued until 4 mil photo mylar reproducible "As-Built" Plans certified and sealed by a Registered Civil Engineer, have been submitted and accepted by the City Engineer".
 - "As-Built" Plans certified and sealed can be submitted electronically by Registered Civil Engineer.
 - 2. Question 2 How much time (Hours/Days) will be allowed to have the existing (OLD) Vehicle Detection System inoperative, while the NEW Vehicle Detection System is being installed and calibrated?
 - New cameras must be installed and calibrated the same day. City Signal Techs will manually control the intersection when the cameras are being replaced.
 - 3. Question 3 Technical Specification, Page No. 2, Bid Items. It States the Following. "Photographing and video taping of the project". Will this be required.
 - Photographing and video taping of the project will be required to capture existing conditions to protect the contractor.

- 4. Question 4 Technical Specification, Page No. 5, Warranty. It States the Following: "The Ethernet switches shall be warranted by the Contractor against all defects in material and workmanship for a minimum of one year. In the event of a malfunction during the warranty period, the defective unit, card, module, subassembly, or auxiliary device shall be replaced with a working unit within three working days for use while the warranted unit is being repaired". Due to the warranty requirements, the contractor will be required to stock spare(s) Ethernet Switche(s).
 - Contractor is in charge of means and methods to meet requirement.
- 5. Technical Specification, Page No. 10, Item's No. 9, 10, and 11. FLIR TrafiSense Dual 2. Please provide what variation the FLIR TrafiSence Dual 2 will be required.
 - The City requires Variation 645.


