CHANDLER BUSINESS REGISTRY

Starting a business can be a challenging route to navigate. This information is intended to give a quick reference of contact information for the City of Chandler departments that you will be working with to obtain the necessary certificates, permits or registrations.

Depending on your business location, you may need:

Zoning Requirements:

Home based business locations within the Chandler city limits must obtain zoning approval.

Commercial locations are required to have a Certificate of Occupancy.

Register your Business with Chandler: Mandatory for all businesses in Chandler, regardless of the type of business. Each business entity and location must register separately. A change of business location address within Chandler must be submitted in writing within 30 days of the change. *Late fee of 50% assessed when application is received more than 45 days after the business start date.

Prior year Registry fees and late fees will be assessed for <u>each year</u> of operation without a Registration. Business Registration code was effective as of January 1, 2018.

Fees are nonrefundable.

Renewal fees that are not received in our office by the last business day of January are assessed a 50% penalty.

Additional specialty licenses are required for pawnbrokers, secondhand dealers (including antiques), liquor sales, amusement games (video, billards, etc.), massage establishments, theaters, peddlers/solicitors/transient merchants and mobile food units.
