Proposition 430 – Home Rule - Organization

Ballot arguments may not exceed 300 words in length and shall be accompanied by a fee of \$150 to offset proportional costs of printing, paper, and translation. Ballot argument form, payment, and an electronic version of the argument is due to the City Clerk's Office by August 5, 2026 at 5:00 p.m. for the November 3, 2026 General Election. The text of the ballot argument can be emailed to elections@chandleraz.gov. Proper spelling, grammar, syntax, and language are the responsibility of the person submitting the argument, not the City Clerk. The electronic version submitted is the version that will be used in the published information pamphlet.

The City of Chandler shall mail a copy of a pamphlet to every household within the city that contains a registered voter. The pamphlet shall contain information on the arguments for and against Proposition 430. The name of the person and entity of the person submitting this argument will be included in the pamphlet. The residential address and telephone number of the person submitting this argument will not be included in the pamphlet with the exception of the person's city and state of residence.

Information pamphlets will be produced and distributed in the manner prescribed by Arizona State Statute.

Proposition 430 – a local measure submitted to the voters by the Chandler City Council for the continuation of the local expenditure limitation (Home Rule) for Chandler for the next four years.
