RESOLUTION NO. 5004

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHANDLER, ARIZONA ADOPTING BY REFERENCE FLOOD INSURANCE STUDY AND FLOOD INSURANCE RATE MAPS, AND FLOODPLAIN MANAGEMENT REGULATIONS CONSISTENT WITH AND PURSUANT TO SECTION 43-5, OF THE CODE OF THE CITY OF CHANDLER.

WHEREAS, the City of Chandler, Arizona (the City), joined the National Flood Insurance Program (NFIP) as a separate community on July 16, 1980, and under the NFIP, is the entity responsible for Floodplain Management within the City;

WHEREAS, the City believes that the continued participation in the NFIP is in the best interest of the citizens of the City;

WHEREAS, the Federal Emergency Management Agency published a Flood Insurance Study and Digital Flood Insurance Rate Maps for Maricopa County and Incorporated Areas, effective on November 4, 2015;

WHEREAS, each community that participates in the NFIP is required to adopt floodplain management regulations consistent with Federal and State criteria;

WHEREAS, pursuant to Section 43-5.1, Code of the City of Chandler, adopted pursuant to Ordinance No. 4365, the responsibility of floodplain management has been delegated to the Flood Control District of Maricopa County as provided for in A.R.S. 48-3610; and

WHEREAS, the Flood Control District of Maricopa County has adopted Floodplain Regulations that meet the minimum requirements of the National Flood Insurance Program.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chandler, Arizona, as follows:

Section 1. That those documents entitled "Flood Insurance Study for Maricopa County, Arizona, and Incorporated Areas dated November 4, 2015" and "Digital Flood Insurance Rate Maps dated November 4, 2015" effective November 4, 2015, and all subsequent amendments and/or revisions, three (3) copies of which shall be kept on file in the office of the City Clerk, are hereby adopted by reference, as the basis for establishing the special flood hazard areas for floodplain management in the City consistent with and pursuant to Section 43-5.1, Code of the City of Chandler. The special flood hazard areas documented in the Flood Insurance Study and Flood Insurance Rate Maps are the minimum area of applicability of the floodplain management regulations and may be supplemented by studies for other areas as allowed in the regulations.

Section 2. That the Floodplain Management Regulations for Maricopa County (June 25, 2014, Revision), and all subsequent amendments and/or revisions, three (3) copies of which shall be kept on file in the office of the City Clerk, is hereby adopted as the legal basis for implementing floodplain management in the City.

Section 3. That those certain documents entitled "Flood Insurance Study for Maricopa County, Arizona and Incorporated Areas dated November 4, 2015" and "Flood Insurance Rate Maps dated November 4, 2015" effective November 4, 2015, and "Floodplain Management Regulations for Maricopa County (June 25, 2014, Revision)" are hereby designated as public records.
