

## NOTICE OF PUBLIC HEARING

### ADOPTION OF FISCAL YEAR (FY) 2024-25 BUDGET AND 2025-2034 CAPITAL IMPROVEMENT PROGRAM AND SETTING OF PROPERTY TAX LEVIES

NOTICE IS HEREBY GIVEN THAT at a Regular Meeting of the City Council of the City of Chandler, the Council shall hold a public hearing. The City Council will meet for the purpose of final hearing of taxpayers, for adoption of the FY 2024-25 Annual Budget and the 2025-2034 Ten-Year Capital Improvement Program (CIP), and for hearing taxpayers on the proposed property tax levies for the City of Chandler, Arizona, on the 13th day of June, 2024, at the hour of 6:00 p.m. in the Council Chambers, 88 East Chicago Street, Chandler, Arizona, and will further meet for the purpose of tentatively setting the property tax levies on the 24th day of June, 2024, then finally setting the property tax levies on the 27th day of June, 2024, both at the hour of 6:00 p.m. in the Council Chambers, 88 East Chicago Street, Chandler, Arizona.

The estimates of the amounts required for the public expense for the City of Chandler for FY 2024-25 and required under §42-17101 and §42-17102 described in Schedules A through G have been tentatively adopted by Resolution No. 5800 on May 23, 2024. Schedules A and B are attached hereto, and the remaining schedules are available on the City website [www.chandleraz.gov/budget](http://www.chandleraz.gov/budget).
