

ORDINANCE NO. 2380

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CHANDLER, ARIZONA, AMENDING THE TITLE AND SECTIONS OF CHAPTER 17A, ARTICLE V, OF THE CHANDLER CITY CODE .

BE IT ORDAINED by the City Council of the City of Chandler, Arizona as follows:

Section 1. That the Chandler City Code, Chapter 17A, Article V, is amended to read as follows:

ARTICLE V. MAYOR'S COMMITTEE FOR PEOPLE WITH DISABILITIES

Section 17A-40. Creation of the Committee.

a) There is hereby established a Mayor's Committee for People with Disabilities, consisting of nine (9) members. This committee shall represent a cross section of the community. The nine (9) members shall be appointed by the Mayor, subject to the approval of the City Council.

b) At least eight (8) of the members of the committee must be qualified electors of the city and have been residents of the city for at least one (1) year immediately preceding the date of appointment. One (1) member who is not a resident may be eligible to serve on the committee provided he/she is a resident of the local metropolitan area for at least one (1) year immediately preceding the date of appointment.

Section 17A-41. Membership terms of office, committee officers.

The terms of each member of the committee shall be for three (3) years, except that the first seven members of the committee shall be appointed for the following terms: Two (2) members shall serve for one (1) year; two (2) members shall serve for two (2) years; and three (3) members shall serve for three (3) years, and thereafter, their successors shall serve a full term. An eighth and ninth member shall first be appointed to serve one (1) year and two (2) years, respectively, and thereafter, their successors shall serve a full term. Any vacancy in office during the term shall be filled for the unexpired term by the Mayor, with the approval of the City Council.

The committee shall elect its own officers at the first meeting following the first of May of each year. The Development & Community Services Director, or duly authorized representative, shall act as secretary to the committee and shall not be allowed to vote. No officer elected by the committee shall serve in the same capacity for more than two (2) consecutive one year terms.

Section 17A-42. Powers and duties generally.

The powers and duties of the Mayor's Committee for People with Disabilities shall be:

a) To adopt rules of procedure for the faithful performance of its duties.

b) To provide that five (5) members shall constitute a quorum and that the affirmative vote of the majority of members present shall be required for passage of any matter before the committee.

c) To assist and advise the City Council on essential policies, rules and regulations relating to advocacy issues experienced by the disabled of our community, such as accessibility, employment and education.

d) To serve as liaison between the City Council and the general community in matters regarding the disabled and to promote and advocate for the disabled whenever and wherever possible.

Section 2. The adoption of this ordinance shall not be construed as creating a new committee, but as merely continuing an existing committee under a new title and with an increased membership.
