

ORDINANCE NO. 2587

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CHANDLER, ARIZONA, AMENDING THE TITLE AND SECTIONS OF CHAPTER 17A, ARTICLE IV, OF THE CHANDLER CITY CODE (ORDINANCE NO. 1919), CONCERNING HISTORICAL MUSEUM ADVISORY BOARD.

BE IT ORDAINED by the City Council of the City of Chandler, Arizona, as follows:

Section 1. That the Chandler City Code, Chapter 17A, Article IV, is amended to read as follows:

ARTICLE IV. MUSEUMS ADVISORY BOARD

Sec. 17A-32. Creation of board

a) There is hereby in operation a museums advisory board, consisting of seven (7) members. This board shall represent a cross-section of the community. The seven (7) members shall be appointed by the mayor, subject to the approval of the city council.

b) At least six (6) of the regular members of the board must be qualified electors of the city and have been residents of the city for at least one (1) year immediately preceding the date of appointment. One (1) member who may not be a resident may be eligible to serve on the board provided he/she is a resident of the local planning area for at least one (1) year immediately preceding the date of appointment. One (1) member shall be recommended by the Chandler Historical Society board of directors. One (1) member may be recommended by the Arizona Railway Museum board of directors.

Sec. 17A-33. Terms of office, officers of board

The terms of office for the regular members of the board shall be for three (3) years.

The board shall elect its own officers at the first meeting following the first of May each year. The community services director, or duly authorized representative, shall act as secretary of the board but shall not be allowed to vote. No officer elected by the board shall serve in the same capacity for more than two (2) consecutive one-year terms.

Sec. 17A-34. Powers and duties generally

The powers and duties of the museums advisory board shall be:

a) To adopt and implement such rules of procedure for the faithful performance of its duties.

b) To provide that four (4) members shall constitute a quorum and that the affirmative vote of the majority of the members present shall be required for passage of any action items before the board.

c) To assist and advise the city council on essential policies, rules, regulations, and other matters relating to the operation of the museums within the city and preservation of significant historic or other cultural sites that reflect our local or regional heritage.

d) To serve as liaison between the city council and the boards of directors of museums within the city and citizens involved with the preservation of our local or regional heritage.

e) To promote the interests and activities of the museums within the city to the general community and to advocate identification, evaluation, and preservation of significant historic or other cultural sites that benefit the community's awareness of its heritage.
